

Hearing - Causing Damage

Loud noise damages your hearing; it can harm the sensitive hair cells in the inner ear that send signals to the brain and allow us to hear.

Unlike strengthening your muscles by gradually increasing the weight you are lifting, it is not possible to toughen up your ears by exposing them to loud noises. In fact, the opposite happens. Permanent, irreversible hearing damage can occur from exposure to loud noises.

Hearing can be damaged by a single exposure to an extremely loud noise, such as an explosion or gunshot, or after long-term exposure to loud sounds, such as the noise generated by machines in a woodshop. Short-term exposure to loud noise can bring on a temporary loss of hearing.

If you have to shout to be heard by a person near you, this is a warning sign that you are in an atmosphere that is too noisy. A ringing or humming noise in your ears after leaving a noisy area is another sign.

A person's risk for hearing loss increases with louder noise levels and longer exposures to loud noise. To preserve your hearing, wear earplugs or other ear protection when you need to be around noise that could cause permanent damage. "Living Right," 2014 J.J.
